

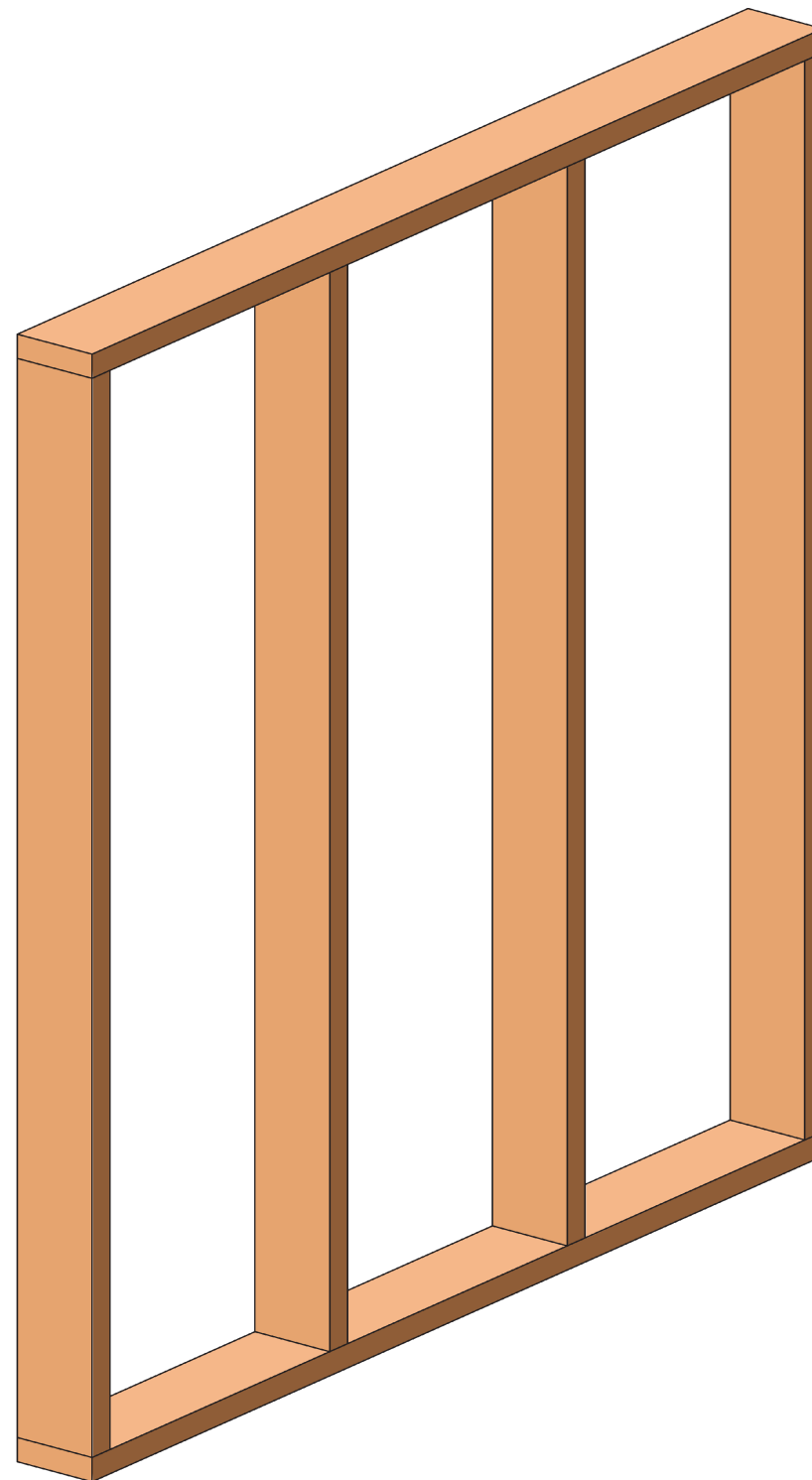

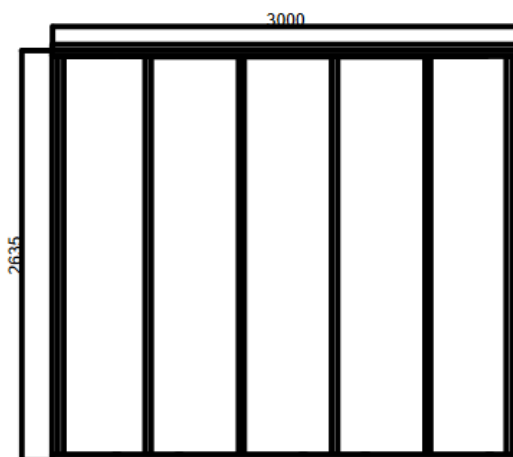

2 Product

2.1 PRODUCT DESCRIPTION

Houtskeletbouw frame voor constructieve en niet-constructieve binnenwanden representatief voor leden NBVT. Het frame is opgebouwd uit houten stijl- en regelwerk van 38 x 89mm. (de 89mm is schaalbaar van 89mm tot 120mm) Het frame heeft een onderlinge stijlfstand van h.o.h. 400mm.

Het element voldoet aan de eisen van BRL 0904 'houtskeletbouw', BRL 1003 'niet dragende binnenwandsystemen' en/of BRL 1008 'Dragende binnen- en buitenwandsystemen' en is representatief voor de leden van de Nederlandse Branchevereniging voor de Timmerindustrie (NBVT) die hiervoor zijn gecertificeerd. 2.2 APPLICATION (INTENDED USE OF THE PRODUCT)

Het product wordt gebruikt als binnenwand, wat betekent dat het wordt gebruikt als een structuur om een ruimte te scheiden en af te bakenen. Het kan worden geïnstalleerd in een breed scala aan omgevingen, zoals woningen, kantoren, winkels en andere commerciële gebouwen.

2.3 DESCRIPTION PRODUCTION PROCESS

Het houtskeletbouw frame voor dragende en niet-dragende binnenwanden wordt geprefabriceerd bij een leverancier van houtskeletbouwelementen met KOMO certificering van betreffende toepassingsgebied. Gemaakt van gezaagd en geschaafd Europees vurenhout, aangeleverd in de dimensies: 38x89mm. Het element wordt in de productiehal uitgelegd op een bok of transportband waar de houten stijlen en regels onderling worden verbonden met een nagel tacker. Hierna is het product gereed voor verdere verwerking zoals het aanbrengen van (buiten beschouwing gelaten) beplating, isolatie en folie. Productieafval dat ontstaat bij productie van het houten frame is het zaagsel en resthout dat ontstaat bij het afkorten.

2.4 CONSTRUCTION DESCRIPTION

Houtskeletbouw elementen worden met een torenkraan op de juiste positie gehesen en bevestigd met elektrisch handgereedschap. Materialen voor bevestiging variëren per aansluiting en per bouwmethodiek en zijn om deze reden buiten beschouwing gelaten in dit onderzoek.

3.6 ENVIRONMENTAL COST INDICATOR NL PER SQUARE METER

Using the environmental cost indicator (ECI) method, which is presented in the NMD Determination Method (2020), the results are aggregated to the single-point score. The ECI is a relevant valuation method, especially in the Dutch construction sector. In the Netherlands, it is a prerequisite for public tenders.
