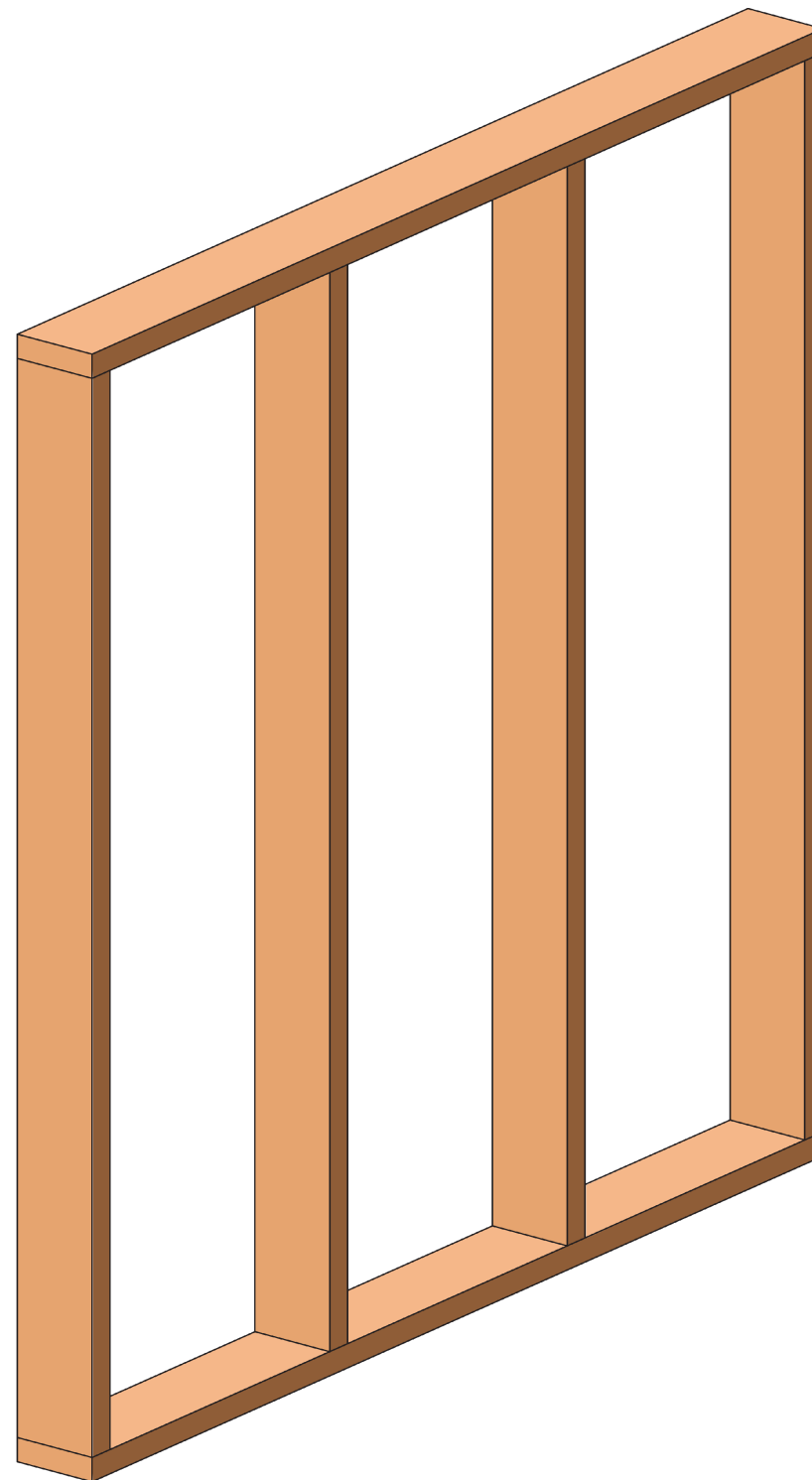

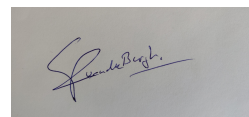

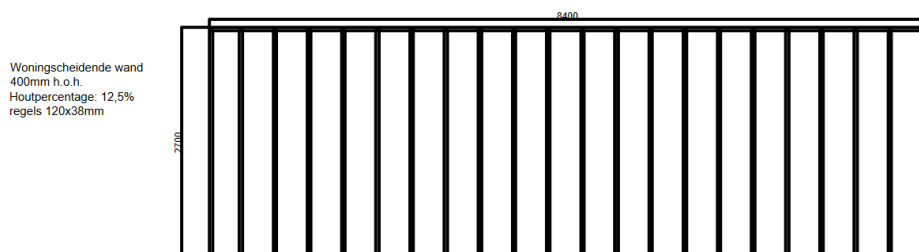
2 Product

2.1 PRODUCT DESCRIPTION

Houtskeletbouw frame van een woningscheidende wand. Het frame is opgebouwd uit houten stijl- en regelwerk van 38 x 120mm (de 120mm is schaalbaar van 89mm tot 140mm) met een onderlinge stijlfstand van h.o.h. 400mm. De functionele eenheid betreft een vierkante meter spouwblad als woningscheiding voor één woning. Voor een volledige woningscheiding moet een dubbele wand (twee m2 functionele eenheid voor één m2 woningscheiding) toegepast worden.

Het element voldoet aan de eisen conform BRL 0904 'houtskeletbouw' en is representatief voor de leden van de Nederlandse Branchevereniging voor de Timmerindustrie (NBvT) die hiervoor zijn gecertificeerd.

2.2 APPLICATION (INTENDED USE OF THE PRODUCT)

Het product wordt gebruikt als woningscheidende wand, wat betekent dat het wordt gebruikt als een structuur om een woning te scheiden en af te bakenen. Het kan worden geïnstalleerd in een breed scala aan omgevingen, zoals woningen, kantoren, winkels en andere commerciële gebouwen.

2.3 DESCRIPTION PRODUCTION PROCESS

Het houtskeletbouw frame voor woningscheidende wand met stijlen h.o.h. 400mm. wordt geprefabriceerd bij een leverancier van houtskeletbouwelementen met KOMO certificering van betreffende toepassingsgebied. Gemaakt van gezaagd en geschaafd Europees vurenhout, aangeleverd in de dimensies: 38x120mm. Het element wordt in de productiehhal uitgelegd op een bok of transportband waar de houten stijlen en regels onderling worden verbonden met een nagel tacker. Hierna is het product gereed voor verdere verwerking zoals het aanbrengen van (buiten beschouwing gelaten) beplating, isolatie en folie. Productieafval dat ontstaat bij productie van het houten frame is het zaagsel en resthout dat ontstaat bij het afkorten.

2.4 CONSTRUCTION DESCRIPTION

Houtskeletbouw elementen worden met een torenkraan op de juiste positie gehesen en bevestigd met elektrisch handgereedschap. Materialen voor bevestiging variëren per aansluiting en per bouwmethodiek en zijn om deze reden buiten beschouwing gelaten in dit onderzoek.

3.6 ENVIRONMENTAL COST INDICATOR NL PER SQUARE METER

Using the environmental cost indicator (ECI) method, which is presented in the NMD Determination Method (2020), the results are aggregated to the single-point score. The ECI is a relevant valuation method, especially in the Dutch construction sector. In the Netherlands, it is a prerequisite for public tenders.
